

Day 1: ECCE Rationale, Costing, and Financing

Project Officer, Global Education Monitoring Report, UNESCO



Yuki Murakami joined the Global Education Monitoring Report team in August 2016 to work on education finance issues. Previously, she was a health economist at the OECD analysing health expenditure trends and financing mechanisms using the System of Health Accounts in both OECD and non-OECD countries.
